

Information from the Data Controller on the basis of art. 14 para. 1 and 2 of **the Resolution of the European Parliament and Council (EU) 2016/679 dated 27 April 2016 on protection of natural persons due to personal data processing and free flow of such data, and repeal of the directive 95/46/CE** (hereinafter: Resolution):

1) Your personal data are processed because they have been provided to Zepter International Poland sp. z o.o. [*limited liability company*], with its registered office in Warsaw (hereinafter: Zepter), as contact data in order to raise the quality of services and hold talks with the consumer. Bearing the above in mind, Zepter processes the following categories of your personal data: first name, last name, e-mail address, phone number, company name, company address.

2) Pursuant to the art. 4 point 7 of the Resolution, the Personal Data Controller is Zepter (contact data: Zepter International Poland sp. z o.o., ul. Domaniewska 37, 02-672 Warszawa, tel. (22) 565 84 84, (22) 565 80 00, hotline (22) 230 99 40).

4) Your personal data are processed on the basis of and for the purpose of the following:

- a) on the basis of the art. 6 para 1 b) of the Resolution for **the purposes of ongoing communication with regard to conclusion of the agreement by and between the Company and Zepter,**
- b) on the basis of the art. 6 para 1 f) of the Resolution **in legally justified interest implemented by the Controller**, i.e. (i) for the purposes of direct marketing of Controller's products and services, (ii) for the purposes of improving services and products.

5) **Expected recipients of your personal data:** entities which Zepter uses to perform the agreement (e.g. postal operator, courier), entities through which the Controller markets the Controller's products and services (e.g. postal operator, telecommunications operator, advertising agencies), entities who the Controller entrusts with a task of rendering advisory, auditing, tax-related services and legal aid.

6) Your **personal data will be stored for the time dependent on the purpose** in which they have been collected **and the legal basis for processing**, i.e.:

- a) ongoing communication with regard to performance of the agreement concluded by and between the Company and Zepter – until the end of the term of the agreement or until the agreement has been completed,
- b) fulfilling legal obligations of the Controller – until these legal obligations have been fulfilled by the Controller,
- c) implementation of the Controller's legally justified interest: (i) direct marketing of the Controller's products and services – until objection is raised, (ii)

improving services and products – until claims expire or until the Controller acknowledges a justified objection.

- 7) **You have a right to** access your personal data and a right to rectify, delete, limit processing as well as right to transfer data.
- 8) You **also have a right to raise** – at any time – **objection justified** with your special situation in relation to processing of your personal data in order to implement the Controller’s legally justified interest, and if under the legally justified interest the Controller processes your personal data for the purposes of direct marketing – **a right to raise objection**. Should the Controller acknowledge the justified objection or raise the objection, your personal data will no longer be processed.
- 9) With a view to exercising your rights referred to in this Information, it is necessary to contact the Seller or Seller’s Personal Data Inspector, basing on the aforesaid data.
- 10) You have a right to **lodge a complaint** to the Head of the Personal Data Protection Office if you decide that processing of your personal data violates regulations on personal data protection, including regulations of the Resolution.
